- 1. Net Sales & other Credit note will be considered on the Net billing of Kharif season from 1st APRIL 2022 to 31st AUG 2022.
- 2. Benefit 1 mentioned in the Scheme is on Booked and Sold quantity only (Net sales post returns). Benefit-2, Unutilized ABS amount if any, will be considered under 1st CD slab, launched during 2022 Kharif sales season as per CD scheme regulation.
- 3. The business value will be calculated on net invoiced value of sold material (Net sale after return) for tour.
- 4. The value of any institutional or subsidy business, Fodder 33 & Fodder Maize will not be considered for tour scheme.
- 5. Only one person will be eligible from each firm for tour scheme irrespective of eligible turnover.
- **6.** There will be no any credit note for this tour scheme.
- 7. Any outstanding related to KH'22 should be cleared on or before December'22 for qualifying in tour scheme.
- **8.** 8. There should not be any outstanding more than 180 days during the end of ABS closing month if any, will be adjusted first from the advance paid under this scheme and credit balance, if any will be added in ABS amount.
