Field Crops	100 %	If sales return is less than 15 %
	75 %	If sales return is between 15 % to 25 %
	50 %	If sales return is more than 25 % and Less
		than 30 %

(If sales return in field crops is more than 30 % then field crop sales will not be considered for net sales calculation under the scheme)
